Rotary servo motors HK-KT series, HK-MT series, HK-ST series, HK-RT series,



The UL mark will be changed from RU (U.S. certification only) to cRUus (U.S. and Canadian certification).

3. Background

The target models with the cRUus mark will be manufactured again because the lead wires used in the target models will be compliant with cRUus (U.S. and Canadian certification) requirements.

4. Schedule

(1) Rotary servo motors

This change will be made sequentially from the January 2026 production.

(2) Direct drive motors

This change will be made sequentially from the April 2026 production.



A factory inspection conducted by Underwriters Laboratories Limited Liability Company found that the lead wires used in the target models are compliant only with RU (U.S. certification) requirements but not with cRUus (U.S. and Canadian certification) requirements.

This change will be made sequentially from the July 2025 production. There may be cases where both the former and new products exist in the distribution stage.

5. Future Action

For the target models, the cRUus mark will be displayed on the products again after the lead wires are compliant with cRUus (U.S. and Canadian certification) requirements.
