Compliance with the EU Packaging and Packaging Waste Regulation

Thank you for your continued patronage of the Mitsubishi Electric AC servo system.
The packaging label of the target models will be changed to comply with the EU Packaging and Packaging Waste Regulation.

1. Target Model

Some models of the servo system controllers (including cables and options) will be subject to this change.

The list of the target models is shown below. Other models are already compliant with the EU Packaging and Packaging Waste Regulation.

2. Reason for the Change

The packaging label of the target models will be changed to comply with the EU Packaging and Packaging Waste Regulation (PPWR). This regulation comprehensively covers the design, recyclability, and disposal of packaging materials, and will apply from August 12, 2026.

3. Details of the Change

In accordance with the EU Packaging and Packaging Waste Regulation, the following will be added to the packaging label, outer packaging, or individual packaging.

There is no impact on the general specifications, performance specifications, functions, and dimensions of products due to the change.

4. Schedule

This change will be made sequentially from the June 2026 production.
