Thank you for your continued support of Mitsubishi Electric Graphic Operation Terminal (GOT).

In the EU Commission Delegated Directive (EU) 2015/863 noticed through official gazettes in June 2015, four phthalates were added to the list of substances restricted under the EU RoHS Directive 2011/65/EU (RoHS 2). The GOT, which falls under Category 9 (Industrial monitoring and control instruments), will be subject to the directive from July 22, 2021.

The following shows a compliance guide for the GOT.

1. Products compliant with the directive

The products, with the CE mark on their product labels and manufactured in January 2021 or later, will be compliant with RoHS 2.

* All cables usable for GOT2000, GOT1000, and GOT SIMPLE series are compliant with RoHS 2.



2. Marking on the product

For the products containing the maximum allowable or lower concentration of the 10 substances (conventional six and additional four restricted substances), the marking on the packaging label and product label will be changed sequentially from July 2020.

2.1 Packaging label

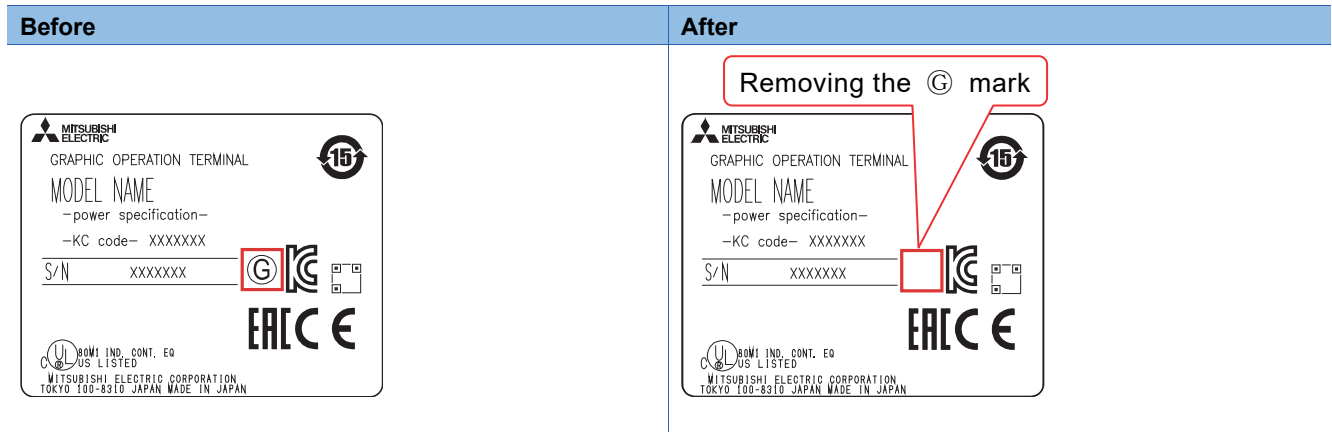
The <G> mark will be changed to <H> mark.

3. Product specifications

No change will be made to the product specifications (including the general specifications, performance specifications, power supply specifications, and functions) along with compliance with RoHS 2. The operating ambient temperature and storage temperature will be changed for the protective cover for oil only.
