# Change in the Packaging Labels for Products Containing Phthalates Restricted by EU RoHS Directive

MELSEC series, MELIPC series, and MELSENSOR series

Thank you for your continued support of Mitsubishi Electric programmable controllers MELSEC series, Mitsubishi Electric industrial PCs MELIPC series, and Mitsubishi Electric FA sensors MELSENSOR series.

Indications on the packing label will be changed to identify products containing phthalates in conformance with the EU RoHS restrictions which are to be applied on and after July 22, 2021. There is no impact on the general specifications, performance specifications, functions, and external dimensions of products due to the change.

#### 1 REASON FOR THE CHANGE

To identify the products corresponding to the official gazette publication of European Union Directive (EU) 2015/863. In addition to the conventional 6 substances, 4 phthalates were newly added to the restricted substances of RoHS directive 2011/65/EU. The directive will start to apply to the "Category 9: Industrial monitoring and control instruments", a category which our equipment products fall under, on July 22, 2021.

### 2 RELEVANT PRODUCTS AND DETAILS ON THE CHANGE

#### Relevant models

MELSEC series, MELIPC series, MELSENSOR series (excluding models that are not compatible to CE, models of which production has been discontinued, and models of which production discontinuation has been notified)

#### Details on the change

For products containing the 4 phthalates at concentrations equal to or less than the maximum allowed in addition to the conventional restricted 6 substances of RoHS directive, the packaging label will be changed from "G" mark to "H" mark \*1. (Position of marks differs depending on the product.) Also, the change is only the mark at this time, and other indications are the same with the conventional products.

\*1 "H" mark is not a RoHS directive mark of conformity.
