The following MELSEC-F series models were found to be incompatible with the UL certification due to differences from the certified content. This technical bulletin informs you that the UL mark will be removed from those models.

There is no impact on the general specifications, performance specifications, functions, and external dimensions due to the change.



The UL mark will be removed from the rating plate as follows. In addition, the size and color of the plate will be changed.




Change of external appearance of the packaging box

As a result of our internal investigation, it was discovered that the relevant models had differences from the certified content. Therefore, the UL certification of those models will be revoked.

There are no safety issues with the products already in the market (product number: 238**** or earlier), and the UL certification applies to these products.

6 FUTURE ACTIONS

We will acquire the UL certification again for those models.

The UL mark will be displayed as soon as the UL certification is acquired, but it is expected that it will take some time. If you require UL certified products, please consider alternatives.

Note that products without the UL mark cannot be used as UL certified products even after reacquiring the UL certification. The schedule for reacquisition of the UL certification is as follows.

For the FX3UC-32MT-LT-2, the UL Listed Mark will be displayed again on the products (product number: 242****) manufactured on or after February 2024. For the FX3U-64CCL and FX3U-16CCLM, the UL Listed Mark has been displayed on the products (product number: 23Y****) manufactured after November 2023. For details, refer to the following.
