TOKYO, June 5, 2023 – <u>Mitsubishi Electric Corporation</u> (TOKYO: 6503) announced today the status of its repurchase of company stock pursuant to the provisions of Article 459, paragraph 1 of the Companies Act, as well as Article 31 of the company's articles of incorporation approved by the Board of Directors on April 28 2023, as shown below.
