## **Mitsubishi Electric Joins Japan Center for Engagement and Remedy on Business and Human Rights as a Founding Member**

*Aiming to fulfill its responsibility to respect human rights by receiving support of a professional capacity*



**TOKYO, October 21, 2022** – [Mitsubishi Electric Corporation](https://www.mitsubishielectric.com) (TOKYO: 6503) announced today that it has joined the Japan Center for Engagement and Remedy on Business and Human Rights (JaCER)\* as a founding member (regular member). JaCER was established in June 2022 to support and promote the redress of grievances by companies.

JaCER provides a non-judicial "Engagement and Remedy Platform" for grievance redress based on the United Nations Guiding Principles on Business and Human Rights.

Through its "Engagement and Remedy Platform," JaCER receives complaints and reports of cases of violations and suspected violations of the international codes of conduct and the internal regulations established by countries, and aims to act in a professional capacity to support and promote redress of grievances by member companies.

Mitsubishi Electric has been handling complaints and allegations of human rights abuses using its own internal processes. However, the company has decided to join JaCER in order to more promptly uncover any such allegations, further strengthen its corrective measures, and improve transparency in redressing grievances in its supply chain.
